***Multiple Student Discount:** Westminster Academy provides a 5% tuition discount to families with more than one child enrolled full-time in PK2 through twelfth grade. Discount applies to each child enrolled beginning with second child.

FEES

New Student Fees

- Application Fee: \$100 per student (non-refundable)
- Enrollment Fee: \$400 per student (non-refundable)
- Capital Fee: \$500 per family (non-refundable)
- Security Fee: \$200 per family (one-time for 2018–2019 school year)

Returning Student Fees:

- Re-enrollment Fee (if paid by February 28): \$300 per student (non-refundable)
- The re-enrollment fee will increase by \$100 on the first of each month, starting March 1.
- Capital Fee: \$300 per family (non-refundable)
- Security Fee: \$200 per family (one-time for 2018–2019 school year)

Student Activity Fees

The student activity fees are fees that are applicable to **all** students in a particular grade level. Please see the Student Activity Fee Schedule for a complete listing of the fees and what they cover.

Optional Program Fees

Westminster Academy offers a wide range of activities in which students may choose to participate. Optional Program Fees cover the costs of the activities and are billed as they are incurred throughout the school year. Please see the Student Activity Fee Schedule for a listing of the fees.

Tuition and Fees Payment Plans and Terms

Tuition, student activity fees and capital fees are due in full by June 1. A 2% discount is available for payments by cash or check.

Westminster Academy offers families the option of financing tuition and fees over 12 months at a 2% service charge using the FACTS Tuition Management Program. Tuition and fees will be automatically drawn monthly from a designated bank account by FACTS beginning June 1. (Monthly installments missed because a student was admitted after June 1 must be paid in full at time of admittance). A late fee of \$25 will be assessed to any account past due more than 15 days.

Financial Responsibility

Once a student is officially enrolled (contract signed and registration fee paid), the family is obligated to pay the full tuition for the entire academic year. Academic records will only be released when the full obligation is satisfied.

Financial Assistance Program

The objective of the Westminster Academy Financial Assistance Program is to assist Christian families who have a demonstrated financial need and are unable to afford the full cost of tuition. The program is available for students in kindergarten through twelfth grade. Financial assistance is offered in the form of annual grants which are determined by a sub-committee of the School Board after an evaluation of the applicant's financial need.
